



**A guide to remembering
Hospice Care Kenya
in your Will**



Making a will is one of the most important things you can do to safeguard your family and ensure that after death your wishes are carried out. It is your opportunity to provide for the people and causes you care about most.

We believe that no-one should die in pain. A gift in your will, large or small, can make a big difference and continue your support for dying patients in Kenya long into the future.

Leaving a charitable gift in your will is one of the most valuable ways you can support our vital work



Elizabeth, an 85 year old widow, lives a subsistence life on her small plot of land. Unable to afford treatment for cervical cancer, the care she receives from Siaya Roselyn Hospice has been a life-line. The care and compassion that Elizabeth receives from a visiting community health volunteer has enabled her to go on living at home and improved her quality of life. Pain relief and psychological support have been vital.

Gifts from Hospice Care Kenya supporters have enabled us to support the training of a further 90 community health volunteers working from Siaya Roselyn Hospice over the past year.

Family and friends first

We know that family and friends are likely to be your first priority when writing your will. But by leaving a gift to us, after providing for your loved ones, you could also help to ensure that your valuable support to our work in Kenya continues long into the future. Every gift, no matter how big or small, could make a lasting difference to terminally ill people in Kenya.

Choosing to leave a gift to charity in your will can be a big decision, and we would encourage you to discuss it with your family and loved ones first.



A lasting legacy of compassion care and support...

A gift of £500 would ensure that 50 patients receive the pain relief they needed

**A gift of £1,000 would sponsor a student to study a Diploma in Palliative Care
and take their skills back into the community**

**A gift of £2,500 would train 100 community health volunteers to provide essential
palliative care to communities in rural Kenya**

**A gift of £5,000 would support a nurse to run day care and provide follow up in the
home for 45 patients a year**

**A gift of £10,000 would purchase a four wheel drive vehicle and provide the annual
running costs for making home visits to remote rural areas**

**A gift of £25,000 would enable us to support eight hospices to provide compassion,
care and support to dying patients**



How to leave us a gift in your will

Once you've made the important decision to leave us a gift in your will, please take the next steps to ensure that your wishes are carried out.

We strongly suggest you ask a solicitor to write or amend your will. They will be able to provide the best advice on the correct wording, and how to include your gift to Hospice Care Kenya. Before doing so, it's a good idea to put together a list of your assets (what you own) and liabilities (what you owe). This will help you work out what your estate will be worth.

There are two ways you can leave a gift in your will to us – before you visit your solicitor, you may want to think about which you prefer – we have provided some example wording for each;

Residuary legacy - This is a percentage share of the balance of your estate, after all specific gifts have been distributed, and any debts have been paid. It will not lose its value over time, and if you leave a proportion to us you can still ensure other beneficiaries are taken care of.

Suggested wording:

"I give free of Inheritance Tax XX% of the residue of my estate to Hospice Care Kenya....."

Pecuniary gift - This is where you can leave a fixed sum of money to the charity.

Suggested wording:

"I give free of Inheritance Tax the sum of £XX to Hospice Care Kenya..."

To ensure that we are correctly identified as the beneficiary of your gift, please include the following information:

"...whose registered office is Hospice House, 34 – 44 Britannia Street, London, WC1X 9JG, registered charity number 1141469, to be used for its general charitable purposes. I declare that the receipt from their Treasurer or other authorised officer shall be a full and sufficient discharge to my executors."

You may also wish to dedicate your gift to a loved one by expressing your legacy as in memory.

Make a copy of your will, and make sure someone you trust knows where your original will is kept.
